1. **INVITATION FOR BIDS**

The Maharashtra State Seeds Corporation Ltd (MSSCL), Akola invites bids from interested buyers of Low Grade Seed, Fail Seed, Non Seed, Sweepage, Reject, Unserviceable Processing Material procured by MSSCL, through online Bidding/ e-Auction conducted through BSE e-Agricultural Markets Ltd platfor <https://bsebeam.procuretiger.com> , the online trading system made available by BSE e-Agricultural Markets Ltd, as per the terms and conditions prescribed hereunder.

2. DOCUMENTS TO BE FURNISHED TO BeAM ALONG WITH APPLICATION FOR REGISTRATION

- 2.1. Duly filled Basic BeAM Membership application form. (Annexure 1)
- 2.2. Self attested copy of Annual report (Balance sheet and Profit & Loss account) for past two years, Self-attested copy of latest Income Tax returns with a self-attested copy of PAN card.
- 2.3. Certificate of registration under GST.
- 2.4. Self attested copy of Trading License issued by competent authority or certificate under shop and establishment act registration, if any.
- 2.5. An affidavit regarding -
 - a. Not having been prosecuted for violation rules / law under Essential Commodities Act or any such others law or orders there under in any court of law.
 - b. Not having been black listed by any organization or Government for non-performance of contractual obligation.
- 2.6. In case of partnership firm or Co-operative or Corporate the applicant should furnish a copy of the partnership deed or byelaw or memorandum as the case may be. In case of partnership firms the share holding pattern should be duly certified by the Chartered Accountant. In case of Co-operative / Corporate body's copy of the Board resolution duly authorizing the Chief Executive or the authorized person to register and participate in the e e-Auction process should be furnished.



- 2.7. The address proof of the authorized signatory viz Telephone bill/copy of pass port / electricity bill/ voter ID proof/adhar card should be submitted along with the application.
- 2.8. The address proof in respect of the firm or Corporate or Co-operative shall be either certificate of registration or certificate of incorporation issued by the concerned authority (attested by CA).
- 2.9. Bank account details of firm or Co-operative or Corporate on Letter Head.
- 2.10. One set of documents to be enclosed along with application form for registration as participant on BeAM. The format of application is furnished vide Annexure-1&2. The applicant has to sign all the pages of tender document duly stamped and submit along with relevant documents and attach the same to duly filled applications. Applications without valid documents will be rejected and kept pending for registration.
- 2.11. A DD in favour BSE e-Agricultural Markets Ltd, payable at Mumbai for Rs. 5000/- plus GST (18%) =Rupees 5900/- towards registration fee to enroll on BSE e-Agricultural Markets Ltd for participation in e-Auction shall be enclosed along with the application separately. The membership registration fee with applicable service tax can also be transferred by online banking system i.e. RTGS/NEFT to below mentioned bank accounts of BeAM.

forwarding application form through post / couriers will not be entertained.

- 2.14. Those who have already registered as Commodity Participants/Members on BeAM and who have renewed their membership for the current financial year need not separately register. However, they shall submit duly signed this tender document for having accepted the terms and conditions of this tender to participate in the proposed e e-Auctions.

3. EVALUATION OF APPLICATION FOR REGISTRATION

- 3.1. The duly filled up application form along with relevant documents and fee /Registration charges shall be submitted to

- 3.2. BeAM will scrutinize **the applications forms** received and relevant documents submitted. The applicants will be informed regarding acceptance / rejection of their application by BeAM. The selected applicants will be enrolled as registered members for the purpose of e-Auction(s) and registration number / user ID and password will be issued by BeAM.
- 3.3. All registered members are eligible to participate in e-Auction(s) as and when scheduled conducted by BeAM. The electronic platform of BeAM will scrutinize the financial bids and successful bidders will be declared based on the highest offer in respect of specified lots offered for Sale.

4. SCHEDULING OF SALE OF STOCKS



- 4.1. The schedule of sale of various agricultural seeds stock through online bidding process will be communicated from time-to-time. Details of Plants and Godowns and timings will be published on the website i.e. www.bsebeam.com.
- 4.2. All registered members of BeAM are eligible to participate in e-Auction(s) subject to fulfillment of criteria as per the terms and conditions of this tender and subsequent amendment to certain clauses of the tender, if any prior to scheduling e-E-Auctions.

5. **ITEM, QUALITY AND QUANTITY:**

- 5.1. The goods are offered on “As is where is basis” from various locations in Maharashtra. The interested buyers, if they desire, may visit the MSSCL Processing Plants and Godowns for inspection of Stocks with prior intimation to MSSCL before participating in e-Auction. The Buyer shall be solely responsible for inspecting the stocks at his sole discretion before participating in e-E-Auction. No complaints of whatsoever nature shall be entertained thereafter. The Buyers will be solely responsible for the same.
- 5.2. The seeds are of following categories –

Definitions:-



- a) Low Grade Seeds - Which are removed by grading machines at the time of processing and include under sized seeds, broken seeds, damaged seeds.
- b) Fail Seeds/Non-Seeds- Which don't follow the criteria of minimum seed certification norms of Government of India.
- c) Rejected Seeds- Which are removed by grading machines at the time of processing and include broken seeds, damaged seeds.
- d) Sweepage - Which get spread at the time of loading/unloading and spilled from gunny bags.
- e) USPM- Unserviceable Processing Material.

- 5.3. The list of locations & e-Auction schedule will be communicated by respective Regional Managers.
- 5.4. Bids received for less than the specified minimum quantity for a particular Lot and location shall not be considered.
- 5.5. On confirmation from MSSCL, Head Office at Akola, the concerned Regional Manager will confirm the H1 bidder as winner.
- 5.6. Bidder shall ensure that the purchased seed shall not be sold in the market by them as seeds for agricultural purposes. If MSCCL learns that the bidder has sold the seeds for agricultural purposes then legal action will be taken against him under The Seed Act, 1966.
- 5.7. Successful bidders shall also note that the seed stock may be chemically treated and shall not be used for fodder, human consumption and extraction of oil. Legal action will be taken against bidders if found by MSSCL that the purchased stock is used for fodder, human consumption and extraction of oil.
- 5.8. Successful bidder of treated seeds would be required to submit a declaration on Rs.500/- stamp paper duly notarized within 3 days of award of e-Auction that sold seeds would not be used as seeds for agricultural purposes, fodder, human consumption and oil extraction and any other wrong purpose.

6. **PRICE:**



- 6.1. Price to be quoted in delivered weight and quality basis on 'As is where is' basis. The evaluation and finalization of bids received shall be made on the basis of the highest price quoted by the bidders. Price quotation will be in Rs. per Quintal (excluding Mandi Tax and GST or any other taxes). The price quotation would be on net weight basis i.e. exclusive of bag weight. MSSCL may declare the disclosed/undisclosed floor price of commodities in consultation with BSE e-Agricultural Markets Ltd.

7. **VALIDITY:**

- 7.1. The Bids of all Bidders at the final close of the e- Auction Session must remain valid for a period of **30 working days** after completion of the e- Auction session. The seller will have to provide his consent on the e- Auction results within **15 working days** of closing of the e-Auction session. The intimation needs to be given to BSE e-Agricultural Markets Ltd either through email or fax.

8. **PRE-REQUISITES FOR BIDDING**

- 8.1. Bidder referred to in this notice is any real individual or legal entity who wishes to buy their requirement of various agricultural seeds. Only the registered members of the BSE e-Agricultural Markets Ltd can become bidders after fulfilling of all the terms & conditions put in place for the e- Auctions. 9. **SAMPLING AND INSPECTION OF GOODS**

- 9.1. The interested buyers are entitled to visually inspect the stock at the specified MSSCL Processing Plant and Godown prior to bidding. The representative samples can be withdrawn by the authorized persons from the MSSCL Processing Plants and Godowns. For inspection of sampling of



goods buyers should contact concern officer of MSSCL of the concerned area. No complaint will be entertained in this regard thereafter.

10. BID BOND

- 10.1. FOR ONLINE BIDDING/e-AUCTION-An amount equivalent to 3% of the bid amount shall be deposited by the bidder member with BSE e-Agricultural Markets Ltd, before placing any bid, in the way of RTGS/NEFT Transfer or Direct Deposit/Transfer in the escrow bank account provided by BeAM to the bidder prior to e-Auction.
- 10.2. The bidder member should transfer the fund deposited as EMD to Margin through the Post Trade Settlement Module- <https://bsebeam.procuretiger.com> in the prescribed manner (Contact Customer Service Group on 8108908978/8989849253)
- 10.3. The bidders shall be allowed by BSE e-Agricultural Markets Ltd to bid only if the requisite EMD amount is available in the escrow bank account of the bidder. The amount deposited as Bid Bond would determine the bidding capacity of the bidder.
- 10.4. Only the Bid Bond of the highest bidder would be blocked by BSE e-Agricultural Markets Ltd. Bid Bond of the unsuccessful Bidder(s), including those whose bid(s) are not accepted due to non-fulfillment/not meeting the conditions attached to the bid(s), shall be returned by BSE e-Agricultural Markets Ltd on the withdrawal request made by the bidder through Post Trade Settlement Module latest by one (1) day from the date of close of the e- Auction.

11. PROCESS OF ELECTRONIC BIDDING SYSTEM

- 11.1. Date and Time of e-Auction: The details of the e-Auctions schedule will be provided by MSSCL and will be uploaded on the website www.bsebeam.com Bidders are requested to check the schedule on the website regularly. Bidders will not be informed about schedule individually by BSE e-Agricultural Markets Ltd or the MSSCL in any case.



- 11.2. The e-Auction will be open for only 30 minutes per location. Bidders have to quote the bids within the given time. However, if any bid is received 3 minutes prior to the schedule e-Auction closing time then the e-Auction schedule shall be extended for 5 minutes over and above the schedule e-Auction closing time. There shall be maximum 3 such extensions.
- 11.3. The bidders shall place their bids online on BSE e-Agricultural Ltd Platform <https://bsebeam.procuretiger.com> the online trading system is made available by BSE e-Agricultural Markets Ltd as per the terms and conditions of the Tender cum E-Auction.
- 11.4. The Bidders are required to quote in Indian Rupees per Quintal or per bag for each item on offer.
- 11.5. Seller will specify a floor price below which no bids may be accepted by BSE e-Agricultural Markets Ltd Platform.
- 11.6. The incremental tick size shall be Re 1/-.
- 11.7. The highest valid bid shall be intimated by BeAM to MSSCL and it will be confirmed and declared as the H-1 bidder by MSSCL for the e e-Auction. However, MSSCL may also reject the H1 bid on their discretion. MSSCL has sole discretion of declaring the H1 bidder as winner or rejecting the H1 bid.
- 11.8. During an e-Auction session, a bidder may modify his bid upwards to an incremental value more than the existing highest bid.
- 11.9. No cancellation of Bids shall be allowed during an e-Auction session.
- 11.10. The final results of the e e-Auction are binding on all bidders and any requests for cancellation received after the conclusion of an e-Auction session shall result in the forfeiture of the Bid Bond.
- 11.11. Any bid placed using the bidder's username and the password shall be deemed to be an unconditional binding of the bidder to whom such username and the password has been allotted by BSE e-Agricultural Markets Ltd, inter-alia, for the purpose of the e-Auction and the bidder shall be solely and fully responsible for all the activities that occur under such username and password. The user is therefore advised to check the username and the



password before the e-Auction and is advised not to reveal it to anyone else so as to prevent misuse of the same.

- 11.12. Bidders have to bid for total available quantity at a particular Seed Processing Plant and Godown.

12. INTIMATION TO THE SUCCESSFUL BIDDER

- 12.1. The Bids of the highest bidder of online bidding/E e-Auction session will be declared as the Successful bidder by the MSSCL. The confirmation to the successful bidder will be primarily sent by the seller or BeAM, through email, to registered e-mail id (As per BSE e-Agricultural Markets Ltd's records).

13. INTERNET CONNECTIVITY

- 13.1. The Seller and BSE e-Agricultural Markets Ltd shall not be responsible for any failure of power, Network, Server, Bandwidth problems, Hosting Server, Internet Connectivity, ISP or otherwise or the slowness to access BSE e-Agricultural Markets Ltd Platform <https://bsebeam.procuretiger.com>. In case the scheduled e-e- Auction is unable to complete due to any reason whatsoever, BeAM in consultation with MSSCL will reschedule the e-e- Auctions on same or differentiate on same or modified terms and conditions.

14. DOCUMENTS CONSTITUTING CONTRACT

- 14.1. The Invitation of Bids, the terms and conditions of the e-E-Auction, Bid of the Successful bidder, Letter/Email Confirmation/Acceptance issued by the Seller to the successful bidder (hereinafter called the buyer) along with any amendment issued prior to signing of contract shall constitute a valid and binding Contract between the Seller and Buyer.

15. TRANSACTION CHARGES

- 15.1. BSE e-Agricultural Markets Ltd shall charge transaction charge of 0.3% + (GST) of the contract value from the Buyer, which the Buyer shall have to pay



directly to BSE e-Agricultural Markets Ltd at the time of depositing 3% EMD with BeAM. The transaction charges of only successfully bidders will be deducted after the approval from MSSCL.

16. PAYMENT AND LIFTING OF THE STOCKS

- 16.1. The Buyer will be required to pay 20% of contract value as security deposit (S.D) within 3 consecutive bank working days from the date of award of e-Auction in the bank account of respective district office of MSSCL. The buyer needs to compulsorily deposit remaining 79% payment within 07 bank working days from the date of letter of the award of the e-Auction by the seller in to the bank account of respective district office of MSSCL. If buyer fails to bring in 20% S.D amount within the stipulated time period of 03 bank working days, the EMD of 3% will be forfeited & trade will stand cancelled.
- 16.2. Respective district office of MSSCL shall issue delivery challans to buyers on the basis of receipt of 100% trade amount in to its bank account.
- 16.3. The buyer will get free lifting period from the date of award of e-Auction as per the below mentioned schedule:

S. No	Quantity purchased in quintals/Unserviceable Processing Material (USPM)	Free lifting period (in working days)
1	Upto 1000 quintals/ USPM upto 1 Lakh bags	10 working days
2	1001 to 2000 quintals / USPM above 1 to 2 Lakh bags	20 working days
3	2001 to 5000 quintals/ USPM above 2 to 5 Lakh bags	30 working days
4	Above 5000 quintals/ USPM above 5 Lakh bags	40 working days



For the above lifting period no godown rent shall be charged. In case the lifting of commodities is not done or completed within free lifting period, bidder will be liable to pay godown rent to MSSCL as per below mentioned details. Also, if the bidder fails to deposit 80% trade amount with respective district office of MSSCL in 07 working days then interest on outstanding amount will be charged as per the below mentioned schedule.

Late lifting & payment period	Godown Rent	Interest against late payment
1 to 15 working days	Rs.7.50/- per quintal per month against the total outstanding quantity for lifting / for USPM Rs.7.50/- per thousand bags per month	12% interest per annum on the total outstanding amount
Above 15 to 30 days	Rs.15/- per quintal per month against the total outstanding quantity for lifting/ for USPM Rs.15/- per thousand bags per month	12% interest per annum on the total outstanding amount

No extension shall be granted to bidders beyond the period of 15 working days for lifting as well as payment as per the above mentioned schedule. MSSCL head office Akola holds the right to grant extension beyond the period of 15 days at their sole discretion, in this case bidder will be charged godown rent of Rs. 15/- per quintal per month against the outstanding quantity for lifting and 12 % interest per annum will be charged on the outstanding payment if any. If in case MSSCL Akola does not allow extension beyond 15 working days the EMD, S.D and trade amount of the buyer will be forfeited without any prior notice.



- 16.4. Buyers shall contact respective District Office of MSSCL for confirmation on receipt of payment and collection of delivery challans after making payment.
- 16.5. Buyers will have to bring their own gunny bags at the time of lifting of the stock, MSSCL may not give delivery of stock in their own HDPE/gunny bags. In case buyer takes delivery in the HDPE/gunny bags of MSSCL, he needs to pay the charges of HDPE/gunny bags as determined by MSSCL. Such bags would be provided only after removal of Tags, Labels, Thiram Packets and leaflets. Buyers shall do cross-marking on each bag both side with red ink before taking the delivery of stock in MSSCL bags.
- 16.6. The buyer can make payment by way of Direct online Transfer/RTGS/NEFT to the bank account of respective district office of MSSCL.
- 16.7. The amount deposited by the Buyer would determine the quantity which can be lifted by the Buyer.
- 16.8. The small bags loosening, weighment, handling, stitching, loading and transportation charges or any other charges like Warai etc as applicable during delivery from the Plant and Godown have to be borne by the buyer as per prevailing rates on the respective Plant and Godown location.
- 16.9. The Seller's responsibility shall cease once the goods leave the Plant and Godown premises and no claim of quality, quantity and or any other nature, from the buyer will be entertained thereafter.
- 16.10. The Buyer shall make payment for the purchased stock during the office hours of MSSCL, excluding Sunday and holidays.
- 16.11. The Buyer will not be allowed to segregate /sort the stocks during lifting. Being a "As is where basis is" e-Auction, no quality related complaints would be entertained.
- 16.12. The Seller shall issue the invoices to the respective buyers



16.13. In case there is a shortage of quantity at the Plant and Godown after the completion of stock lifting by buyer, MSSCL will have to return the amount equivalent to the short quantity, directly into the bank account of buyer.

16.14. EMD - 3% of the buyer will be released after the total purchased quantity is lifted by him and after the no dues letter received by BeAM from concerned District Office of MSSCL.

16.15. MSSCL will not be responsible for the situation of natural calamity like hailstorm, rains or riots, strikes, disturbances due to law and order situation or situations which are out of control of MSSCL once the quantity has been allotted to the bidder.

16.16. Buyer shall prove its authenticity at the time of lifting of the stock and carry its firm's letterhead with stamp and seal.

16.17. The concerned Regional Manager of MSSCL has an authority to give delivery of 20% extra stock of a particular item to the buyer, if the extra quantity is available at the Plant and Warehouse. However for the quantity above 20% in particular item, the Regional Manager will have to seek the permission of MSSCL HO Akola.

16.18. Buyer/Seller Non-Performance: Following cases will be treated as buyer/seller non-performance -

- i. Non-payment of fund-pay in obligation amount within stipulated time, which shall result in forfeiture of Earnest Money Deposit and Security Deposit.
- ii. Non-lifting of traded Stocks within maximum delivery days mentioned above, which shall result in forfeiture of Earnest Money Deposit, Security Deposit and trade amount and fresh e-Auction will be conducted at the cost of buyer.

17. OBLIGATION OF THE SELLER (MSSCL)

17.1. It shall be sole and absolute responsibility of the Seller i.e. MSSCL to deliver the traded stocks to the buyer upon receipt of corresponding sale proceeds.



- 17.2. In case the Seller fails to deliver, refuses or is unable to deliver the traded stocks within the stipulated time lines, the buyer shall contact the seller for quick delivery of the stock or return of its trade amount.
- 17.3. It will be the exclusive responsibility of the seller to return the trade amount to the buyer if in case of non-delivery of traded stocks for any reasons whatsoever.
- 17.4. MSSCL will not pay any interest on EMD, Security Deposit and Sales Proceed to the buyer at the time of returning the same to the buyer.
- 17.5. BeAM is only acting as a service provider for the facilitation of trade and BeAM shall not be held responsible for non-delivery or delay in delivery of traded stocks by MSSCL for any reason whatsoever.
- 17.6. In case of non-delivery or delayed delivery mentioned above, BeAM will return the EMD amount of the buyer without any interest.
- 17.7. The Buyer shall have no recourse against BeAM for any delivery related issues and the Buyer agrees not to claim or demand delivery of stocks or refund of trade value from BeAM.
- 17.8. MSSCL agrees to indemnify BeAM and keep BeAM indemnified and harmless at all times from and against any claim, petition, proceedings, application or complaint initiated or filed by the Buyer against BeAM and/or against any losses, charges, expenses, costs etc. paid, suffered or incurred by BeAM (including reasonable Attorney's fees) with respect to any action, claim, petition, proceedings, application or complaint etc. initiated or filed by the Buyer against BeAM with respect to non-delivery of traded stocks.

18. SALE OF GROWER'S STOCK

- 18.1 MSSCL at the time sale of commodities will specify if the stock is of MSSCL or of the Grower. If the stock belong to grower i.e farmer following terms will also be applicable apart from all other terms mentioned in the document.



18.1.1 Even though MSSCL holds the right to sell grower's stock, grower at any point before the actual stock is lifted can take back its stock without any prior intimation to the buyer. In this case MSSCL will intimate the same to the buyer about unavailability of that stock at any point of time during the e-Auction process upto time allowed in lifting. MSSCL will have all right to withdraw any or entire quantity of stock even if it is put on e-e-Auction.

18.1.2 In this case neither MSSCL nor BeAM will be liable to give delivery of the stock to the buyer, grower will have full right to take back its stock after completing the due procedure with MSSCL.

18.1.3 Upon such incident, MSSCL will release the trade amount directly in to the bank account of buyer for the non lifted quantity without any delay. MSSCL or BeAM shall not be liable to pay any interest amount on the non-delivered quantity.

18.1.4 The Buyer shall have no recourse against BeAM for any delivery related issues and the Buyer agrees not to claim or demand delivery of stocks or refund of trade value from BeAM in this case.

18.1.5 BeAM will release 3% EMD of the buyer without any interest, BeAM will deduct its transaction charges only on the quantity delivered.

18.1.6 MSSCL will try to provide the entire quantity put on e-Auction, MSSCL reserves all rights to accept or reject any or all offers without any prejudice.

19. FORCE MAJEURE

19.1. Should any of the force majeure circumstances, namely act of God, natural calamity, fire, Government of India Policy, restrictions(excluding any stock limits), strikes or lock-outs by workmen, war, military operations of any natural and blockades preventing the Seller/Buyer from wholly or partially carrying out their contractual obligations, the period stipulated for the performance of the Contract shall be extended for as long as these circumstances prevail, provided that, in the event of these circumstances



continuing for more than two months, either party shall have the right to refuse to fulfill its contractual obligations without title to indemnification of any losses it may thereby sustain.

- 19.2. The party unable to carry out its contractual obligations shall immediately advise the other party of the commencement and the termination of the circumstances preventing the performance of the contract. A certificate issued by the respective Chamber of Commerce shall be sufficient proof of the existence and duration of such circumstances.

20. LIQUIDATING DAMAGES

- 20.1. In case the successful bidder fails to lift the stocks within the stipulated maximum period, the seller will be free to rescind the contract and dispose of the cargo at the risk & cost of the bidder without any prior notice to the buyer. In this case, 3% EMD & 100% of the trade value deposited by the buyer will stand forfeited. The 3% of the EMD forfeited along with the balance 100% of the contract value would be transferred to the Seller by BSE e-Agricultural Markets Ltd and 10% of the EMD amount would be kept by BSE e-Agricultural Markets Ltd towards Administrative charges incurred by BSE e-Agricultural Markets Ltd.

21. CANCELLATION OF CONTRACT

- 21.1. If the Buyer fails to pay 20% security deposit in stipulated time period as mentioned in the contract, the Seller shall be entitled at his option to cancel the contract and forfeit the 3% EMD.
- 21.2. If the buyer fails to deposit 80% trade amount in stipulated time period then trade shall stand cancelled in such case and EMD of 3% and 20% Security Deposit will be forfeited .
- 21.3. The forfeited amount would be used to compensate the seller. The 90% of the EMD in case of clause of (21.1) and (21.2) would be transferred to the Seller by BSE e-Agricultural Markets Ltd and balance 10% would be kept by



BSE e-Agricultural Markets Ltd towards Administrative charges incurred by BSE e-Agricultural Markets Ltd.

22. ARBITRATION

- 22.1. The party shall expressly waive the provision of section 12 clause 5 and shall agree to refer to any dispute which may arise pertaining to terms and performance of contract to Hon'ble Managing Director, MSSCL as "Sole Arbitrator". Decision of Sole Arbitrator shall be final and binding on both the parties.
- 22.2. The venue of Arbitration shall be Akola or any other suitable place decided by the Corporation.
- 22.3. Court situated at Akola to the exclusion of all other courts in India, only shall have the jurisdiction in the matter.
- 22.4. BeAM shall not be responsible for any dispute arising between the buyer and seller relating to quality and quantity of stocks mentioned above or anything related thereto. BeAM shall not be made party to any litigation, suit, petition, application, arbitration or appeal arising from the dispute between buyer and seller. BeAM is merely providing electronic trading platform for the purpose of facilitation of e e-Auctions and both the buyer and the seller agree and accept to indemnify and keep BeAM indemnified from all the claims, losses or expenses that BeAM may incur/suffer as a result of any dispute between buyer and seller.

23. INDEMNITY

- 23.1. The successful bidder shall defend, indemnify and hold MSSCL harmless during and after the tender against any and all liabilities, damages, claims, fines, penalties, actions, procedures and expenses of any nature arising out of, resulting from any violation of any laws by the successful bidder or its punishment or any way connected with the acts, negligence, breach, failure to perform obligations relating to the tender.
