# Terms & Conditions for the Annual Rate Contract for Sale of Scrap Materials

Ananda Dairy invites bids through **Forward -e-Auctions** hosted on the **BEAM platform** for the sale of various categories of scrap materials. A detailed list of the scrap types is annexed for reference. The intent is to establish an **Annual Rate Contract** with eligible suppliers.

## Registration and Participation Guidelines

- 1.1 Interested bidders must register with **BEAM** by submitting required documentation and depositing the Earnest Money Deposit (EMD) in the specified account.
- 1.2 **Registration Fee:** ₹2,000 + 18% GST = ₹2,360, payable to BSE E-Agricultural Markets Ltd (Bank details provided below).
- 1.3 Upon EMD submission, the bidder will receive credentials to participate in the auction.
- 1.4 Bidders must provide accurate contact details for communication.
- 1.5 No withdrawal of bids is allowed once submitted during the e-auction.
- 1.6 All processes will be governed by the laws of the Union of India.
- 1.7 Ananda Dairy reserves the right to accept or reject any bid without providing justification.
- 1.8 Bidders involved in corrupt, fraudulent, collusive, or coercive practices will be disqualified and blacklisted.

## 2. General Conditions

- 2.1 The contract will be valid for various period as per details below , with e-auction scheduled on 7th August ,2025, exclusively for BEAM-registered members.
- 2.2 All scrap materials from Ananda Dairy's four units will be consolidated at the **Pilkhwa Plant** expect **MS/ SS scrap and Mixed Kachra..**
- 2.3 Bidders must quote **basic rates excluding GST**; scrap must be lifted **twice a week**.
- 2.4 Failure to lift scrap as scheduled will attract a **penalty of ₹5,000 per instance**.
- 2.5 **Fixed pricing** will remain in effect throughout the contract period.
- 2.6 Contracts will be awarded to **H1 and H2** bidders, subject to Ananda's discretion.
- 2.7 Discontinuation of scrap lifting during contract tenure will result in **EMD forfeiture and blacklisting**.
- 2.8 Bid validity must extend **7 working days post e-auction**.
- 2.9 **EMD Amount:** ₹ **10000 ( Ten thousand )** – to be deposited in BEAM accounts.
- 2.10 EMDs of unsuccessful bidders will be returned within **one working day**.
- 2.11 EMDs of successful bidders will be adjusted after deducting **0.11% transaction charges (plus GST)**.
- 2.12 Non-execution of contract will result in **forfeiture of EMD**, transferred to Ananda Dairy.

## . Security Deposit (SD)

- 3.1 The successful bidder's EMD will be converted into a **Security Deposit (₹1,00,00)**, which will be transferred to Ananda by BEAM.
- 3.2 SD will be retained until successful contract completion and refunded post-deductions without any interest.

3.3 Any failure/delay in lifting scrap will attract forfeiture of the SD.

3.4 Vendors may inspect scrap at Ananda Dairy, Pilkhuwa, during working hours.

## **DOCUMENTS TO BE FURNISHED ALONG WITH THE APPLICATION FOR REGISTRATION**

2.1 Dully filled BSE E Agricultural Markets Ltd Application form.

2.2 Attested copy of Certificate of registration under GST Tax Act as applicable in the state.

2.3 Attested copy of PAN Card.

2.4 Attested copy of Aadhar Card.

2.5 The address proof of the firm shall be either a certificate of registration or certificate of incorporation issued by the concerned authority or a Telephone bill/ electricity bill. It should be submitted along with the application.

2.6 Bank account details of the firm along with IFSC code, Branch details, and address shall be furnished on the letterhead of the firm duly signed and stamped by the competent authority.

2.7 The new applicants have to deposit the registration fee of Rs 2000/- (exclusive applicable GST) along with the documents. GST @18% shall also be paid amounting to Rs 360/-, The total being INR 2360/-. The registration fee can be directly transferred to the BEAM bank account given below. The members will be allowed to participate for the next 12 months from the date of registration at BEAM's platform. The existing members (TCM, CP) of BEAM who have renewed their membership for the year 2022-23 need not pay the registration fee to BSE E Agricultural Markets Ltd (BEAM).

### **Award of Contract**

4.1 If H2 or other bidders refuse to match H1 rates, the entire quantity may be allocated to H1.

4.2 Only vendors qualified through Ananda Dairy assessments will be considered.

4.3 A formal agreement will be executed on ₹100 stamp paper before scrap lifting. Breach of contract may lead to termination and SD forfeiture.

### **Lifting & Payment**

5.1 Vendors must adhere to the lifting schedule; failure attracts **₹5,000/day penalty**.

5.2 **Full payment must be made prior to scrap lifting.**

## 6. Arbitration and Dispute Resolution

6.1 Any disputes arising will be resolved by a **sole arbitrator** appointed by CMD, Ananda Dairy, under the **Arbitration and Conciliation Act, 1996**.

6.2 The seat of arbitration will be **Delhi**, and proceedings shall be conducted in **English**.

## 7. Indemnification

The supplier shall indemnify Ananda Dairy and its personnel against any loss, damage, claim, or legal action arising from:

- Breach of contract terms
- Violation of laws or regulations
- Negligence or misconduct
- Damage to Ananda Dairy's assets or interests

## 8. Termination

Failure to fulfil obligations may lead to contract termination and Ananda engaging alternative suppliers at the defaulting vendor's cost. The supplier shall facilitate smooth transition and return of Ananda's materials/documents.

## 9. General Terms

- This contract does not create a joint venture or partnership.
- If any clause is held unenforceable, others remain valid.
- Ananda Dairy is not liable for indirect damages including loss of business.
- Force Majeure conditions apply (natural disasters, war, strikes, etc.).
- Intellectual property rights, including Ananda Dairy trademarks, remain exclusively with Ananda Dairy.
- No rights or obligations may be assigned without Ananda's written consent.
- This document constitutes the entire agreement, overriding all previous understandings.

## 10. Jurisdiction

Subject to arbitration, the courts of **Delhi** shall have exclusive jurisdiction.
